Biographical Note

Henry C. Vogt served as mayor of St. Charles, Missouri from 1951 – 1958 and from 1963 – 1970. During his tenure, he oversaw numerous projects designed to modernize the city, particularly with regards to sewage treatment, hospital expansion, urban renewal, and historic preservation.

Scope and Content Notes

This collection is comprised of five boxes, the first three of which were organized by the mayor's office. The fourth box was later assigned applicable subject headings and sub-arranged alphabetically and then chronologically. The fifth box is principally correspondence and arranged chronologically.
